Property taxes and Household Fees are received in large chunks mainly in July and December of each year so a monthly average is not a good gauge of performance for those revenue sources.

Sales taxes will drop in January and thereafter as the state's Medicaid relief plan takes away our article 44 and portions of articles 40 & 42. The target for Oct - Dec would be \$663,050 and Jan - June would be \$446,000
