It is understood between the applicant and the County of Caldwell that this application, upon execution by the applicant or his/her representative and the Co. Manager or his/her representative will constitute a contract between the applicant and the County, by which the applicant agrees to comply with all rules and regulations as set forth in "An Ordinance for the Regulation of the Caldwell County Water System", adopted by the Caldwell County Board of Commissioners on 11/15/1993 and recorded in the office of the Caldwell County Register of Deeds (copy available upon request).

It is further understood that this application is a request for public water service only. All piping and fixtures to make service **available** to the applicant shall be provided, owned and maintained by Caldwell County. From the point of connection with the County-owned fixtures, all piping and fixtures required for the **delivery** of the water service by the applicant shall the responsibility of the applicant and his/ her successors or assigns, regarding installation, operation and maintenance. The costs of all water consumed and/or water lost due to failure of the applicant's piping shall be borne by the applicant or his/her successors or assigns through a monthly water usage charge. **\*The applicant agrees to install and maintain a pressure-reducing valve at the point of connection with the County water system. The applicant further agrees to accept responsibility for the installation, operation and maintenance of any fixtures or appurtenances that might be required to increase or decrease the pressure available from the County system.**

The plumbing permit for new construction (including manufactured housing) will include a fee of **\$20.00** for inspection of the applicant's water line from the point of connection with the County system to the point of connection with the structure.

**The applicant shall grant Caldwell County, its successors or assigns a perpetual easement in, over, under and upon the described land with the right to erect, construct, install, lay and thereafter use, operate and inspect, repair, maintain, replace and remove water pipe lines and appurtenances, together with the right to ingress and egress over adjacent land for the purposes stated above.**
