

How Healthy Are Caldwell Children?



A woman's health and well-being before pregnancy sets the stage for her baby's future health outcomes.





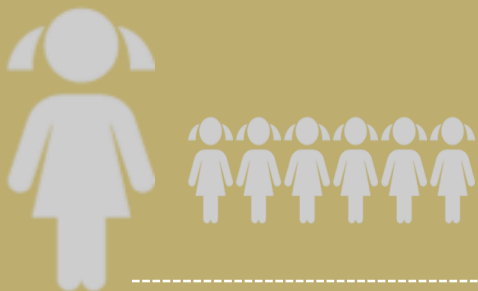
1 in 19 births in Caldwell County (5.2%) is to a woman who received very late or no prenatal care, putting both mother and baby at higher risk for pregnancy complications or poor birth outcomes.

Low birth weight has been found to be the strongest predictor of infant mortality. **1 in 12 Caldwell babies** is born at a low birth weight.



27.9% of Caldwell children live in poverty. Poverty is linked to greater risk for health challenges like:

-  Diabetes
-  Heart Disease
-  Obesity
-  Developmental delays



Health insurance coverage helps children achieve and maintain their best health. **1 in 16 Caldwell** children (6.4%) is uninsured, 1,087 of whom may be income eligible for Medicaid or NC Health Choice.



LIFE EXPECTANCY AT BIRTH

A baby born today in Caldwell County would live 5.6 less years than a baby born in the county with the highest life expectancy.

We can improve child health



- Expand Medicaid to cover adults below 138 percent of the federal poverty line.
- Support interventions to reduce infant mortality, like the CFTF Healthy Babies Bundle.
- Invest in early intervention services to reduce the effects of developmental delays

Quick Facts

82,407 people live in Caldwell County. 1 in 5 residents (18,234) is a child under the age of 18.

The child population is 6.8% African American, 0.2% American Indian, 1.2% Asian, 8.2% Latino and 82.5% non-Hispanic White.

The median household income is \$34,357.

5,220 children in Caldwell (28.6%) live in food insecure households.
